TRUSTEES QUERIES/COMMENTS

Trustee Fraser

Requested information on music programs being incorporated into daily school activities.

The Superintendent responded that many schools have taken creative approaches to incorporating music into schools, e.g. inviting local artists and musicians to perform. There is a broad array of teachers with musical backgrounds who have integrated musical opportunities within their own schools. Parents and teachers are encouraged to speak with their school administrator regarding the music program in their schools.

Trustee Brinkerhoff

Queried whether there has been feedback regarding the reduced charge for transportation fees this year

The Superintendent advised that there has not been specific feedback regarding the reduction in price. Approximately 5,000 students have applied for bus transportation this year, which compares with 4,400 students applying last year. 4,630 students currently have assigned bus seating.

Trustee Pendharkar

Requested information on how the length of the 30 km/hour school zones is determined for either side of a school. As well, Trustee Pendharkar advised the need for a sidewalk to be built on the side of Gibson Road, and requested information on the Board's procedure for requesting the construction of a sidewalk.

The Secretary-Treasurer will research information for both queries and report back to the Board with his findings.

The COPAC President requested clarification on the cancellation of a bus for several students attending the French Immersion Program at Belgo Elementary School. The Secretary-Treasurer advised that last year's bus had been assigned to transport a student with special needs, and at the time, had room to pick up additional students. The special needs bus is either no longer required by the student, or the student has transitioned to a new school for the 2012/2013 school year and the bus has been reassigned.

The COPVPA Representative thanked the Board for their inquiry as to music programs available to students, and advised that many schools have music specialists on staff who provide excellent music programs each week to students in their schools.

School Opening Report

- The information contained within the Superintendent's School Opening Report was reviewed.
