RECOGNITION/ PRESENTATION/DELEGATIONS

SUPERINTENDENT'S REPORT

- The Ministry of Education recently announced that 44 of the District's 2010/2011 graduates have received provincial scholarships for outstanding academic achievement. Additionally, 96 students received Dogwood District/Authority Scholarship Program Awards and 5 students received Secondary School Apprenticeship Scholarship Awards. The names of award recipients will be published in the new year.
- The Superintendent commended all those involved in supporting athletic programs. In particular, the KSS AAAA Girls' Volleyball Team was recognized for bringing home the provincial championship banner. This is the first time in over fifty years that the banner has returned to Kelowna.

<u>Trustee Baxter</u> reported that the Westcan Gravel Pit was beginning its operation soon, which will result in additional dump truck traffic along Westside Road.

The Board agreed to refer the matter to the Coordinating Committee to make a recommendation to the Board to limit trucks on Westside Road during peak traffic periods around the schools in the morning and evening, and during school bus run times.

<u>Trustee Baxter</u> expressed concern that the District of West Kelowna was soliciting input from residents on the Rosewood Drive Elementary School site without including consultation from the School District.

The Secretary-Treasurer reported that staff had been involved in consultation with the District of West Kelowna. The Board discussed the Neighbourhoods of Learning opportunities. The Board further requested that staff add the District of West Kelowna survey link to the School District No. 23 website and that the matter also be discussed at a future Board of Education/District of West Kelowna Partner Group meeting.

The Superintendent reported that Policy 230 Principal and Vice-Principal Evaluation of Performance and Regulations 230R Principal and Vice-Principal Evaluation of Performance requires that information is collected by completing a consultation process with the parent advisory council, staff, and students of the school of the Principal or Vice-Principal who is under assessment. As a result of the current teacher job action, the consultation process would be difficult to complete without teacher participation. Staff who normally complete the process are also busy with additional duties resulting from job action. The Superintendent recommended that Policy 230 and Regulations 230R be suspended for the 2011-2012 school year, and as an alternative, a Growth Plan be created for those individuals.
