RECOGNITION/PRESENTATION/DELEGATIONS

Presentation: "Inside 23"

International Education

Assistant Superintendent, Dr. Rick Oliver, acknowledged the work and commitment of the International Education Homestay Coordinators, teachers and home-stay families, all of whom have helped to build the International Education program. Approximately 500 students, from 32 countries, are now part of our community. Karlee Sieben, one of the International Homestay Coordinators, and Carolina Morena Pelaez, the International Education Activities Coordinator, were introduced and they explained their roles within the International Education division. One of the goals is to endeavour to ensure that the students are connected not only to the school they are registered at, but to the community as a whole.

The Assistant Superintendent presented the promotional video being used to market the International Education Program which highlights all that the Central Okanagan Public Schools and the Okanagan Valley has to offer.

The Board of Education welcomed and congratulated the above staff members to their new positions within the District.

Recognition: Colleen Edstrom, Roots of Empathy

The Board of Education recognized Colleen Edstrom for her work with the Roots of Empathy program. Ms. Edstrom provided an overview of the program, highlighting the benefits of the interaction between newborns and their parents, and the school aged children over the course of nine months. Eighteen instructors lead the program, which consists of 27 lessons. Students in Kindergarten to Grade 1, Grade 3 and Grades 5 and 6 participate in the Roots of Empathy.

TRUSTEES QUERIES/COMMENTS

Trustee Fraser

Queried whether the District has any plans to increase the scope of the Roots of Empathy Program in schools on the Westside.

The Board Chair commented that further instructors would be required, as well as newborns and parents, to participate. The Superintendent of Schools/CEO advised that the Roots of Empathy is not a District program, but a community one and expansion is determined by the Roots of Empathy Coordinator depending on the number of trained instructors that are available.

Proposals for Substantive Change

Trustee Tiede, Chair of the Education and Student Services Committee, provided an overview of discussions held at the October 5, 2016 Committee Meeting. It was noted that the 'Taste of Trades' program will enable Grade 10 and 11 students to obtain a sample of different trades that may be of interest to them as future careers. This program will be held in the Quigley Elementary school annex starting in the second semester of 2016/2017.

Springvalley Middle School - Outdoor Education Academy Fee Increase

Trustee Tiede, Chair of the Education and Student Services Committee, provided an overview of discussions held at the October 5, 2016 Committee Meeting. If approved, the fee would increase by \$75.00 per year from \$150 to \$225.

In response to queries from the Board, the Deputy Superintendent confirmed the new fee is comparable to other outdoor education programs. The hardship policy is in place which allows parents to request partial or full subsidies of the fee. Further, feedback from students, parents and teachers has been that this program provides students with the opportunity to experience outdoor education and travel beyond the City of Kelowna.

The Deputy Superintendent further noted that if the new Policy 506 is approved, the District will subsequently move forward with a reporting policy. Principals, Vice-Principals, teachers, parents and senior staff will be involved in this process.
