Reports/Matters Arising

September 4, 2013 Committee Report - received as presented.

Committee Members Queries/Comments

1. Trustee Butler inquired if the Early College High School program began in September 2013.

The Assistant Superintendent reported that Director of Instruction (K-12) Norm Bradley will provide an update at the October 2, 2013 Education and Student Services Committee Public Meeting.

Discussion/Action Items

1. Amendments to Policy 540 - Proposals for Substantive Change: Distinct Schools, Unique Programs and Specialty Academies

Assistant Superintendent Terry-Lee Beaudry reviewed the proposed amendments to Policy 540 - Proposals for Substantive Change: Distinct Schools, Unique Programs and Specialty Academies as recommended by the subcommittee who worked on the revisions. The Assistant Superintendent noted that the section on Specialty Academies was amended to clarify that Specialty Academies will only be offered at the middle and secondary level. The Committee discussed the proposed amendments and provided input.

Outcome

The Committee recommended that amended Policy 540 - Proposals for Substantive Change: Distinct Schools, Unique Programs and Specialty Academies be sent to the Board of Education for placement as an Action Item on a future Public Board Meeting Agenda.

2. Amendments to Policy 541 - Board Authorized Courses

Assistant Superintendent Terry-Lee Beaudry reviewed the proposed amendments to Policy 541- Board Authorized Courses as recommended by the sub-committee responsible for amending this policy. The committee discussed the proposed amendments to Policy 541 and suggested several revisions. As a result, the committee recommended that the sub-committee reconvene to further review and revise Policy 541. A new draft of Policy 541 will be presented at the October 2, 2013 Education and Student Services Committee Public Meeting.

Outcome

Following the sub-committee's meeting, the revised amendments to Policy 541 - Board Authorized Courses, will be presented to the Education and Student Services Committee at the October 2, 2013 Public Meeting.

3. New Policy 542 - Proposals for Educational Programs with External Partnerships, Appendices 542A - Proposals for Educational Programs with External Partnerships, and 542B - Memorandum of Understanding for Educational Programs with External Partnerships

Assistant Superintendent Terry-Lee Beaudry provided the rationale for the development of Policy 542. This new policy describes the Board's expectations when sharing the delivery of an educational program with an external partner. Appendix 542A - Proposals for Educational Programs with External Partnerships outlines what is expected when drafting a proposal. Appendix 542B - Memorandum of Understanding for Educational Programs with External Partnerships template describes the roles and responsibilities of the District and external organizations when entering into an agreement. The committee discussed the new policy and provided input.

Outcome

The Committee recommended that New Policy 542 - Proposals for Educational Programs with External Partnerships, Appendices 542A - Proposals for Educational Programs with External Partnerships, and 542B - Memorandum of Understanding for Educational Programs with External Partnerships be sent to the Board of Education for placement as an Action Item on a future Public Board Meeting Agenda.
