12. Amendments to Policy 480 – Raising the Bar: The Three-Year Rule

The Board of Education approved the amendments to Policy 480 – Raising the Bar: The Three-Year Rule and also approved the deletion of Form 480A – Application for Exemption and Form 480A – Appeal. The new title of the Policy is "Secondary Student Transitions and Graduation".

13. Letter to Capital Management Branch – Additional Funding for Playground Equipment Program

The Board of Education agreed to send a letter to the Ministry of Education's Capital Management Branch requesting additional funding for the Playground Equipment Program.

14. Property Bylaw No. 152 – BC Hydro Statutory Right-of-Way on H.S. Grenda Middle School Site The Board of Education gave first, second, third readings, and adopted School District No. 23 (Central Okanagan) Property Bylaw No. 152 (registration of a Statutory-Right-of-Way), in favour of BC Hydro on Lot A, District Lot 118, Osoyoos Division Yale District, Plan KAP48997, known as H.S. Grenda Middle School.

The Board of Education reviewed the following:

- 1. Superintendent's COVID-19 Update
 - The Superintendent of Schools/CEO provided an update on the COVID-19 situation in Central Okanagan Public Schools. The majority of exposures are resulting from family gatherings and community events. The District continues to collaborate with Interior Health.
- 2. Level 4 and 5 Field Study Summary 2020/2021
- 3. General Statement November 10, 2020

- 5. Annual General Meeting Draft Minutes November 10, 2020
 The Annual General Meeting Draft Minutes will be approved at the November 10, 2021 Annual General Meeting.
- 6. Board Policy and Regulations 631 School Closures/Consolidation There are no school closures recommended for the 2021/2022 school year.
- 7. Board Policy and Regulations 632 School Reconfigurations
 - The District continues to grow at a rapid rate in most of its communities and many schools are significantly over capacity. There may be grade reconfigurations or catchment changes for the 2021/2022 school year. Final recommendations will be presented to the Board of Education on December 9, 2020 and a final decision by the Board of Education is expected by January 13, 2021.
- 8. eSchool23 (formerly referred to as eSchoolBC) Update
 The change of name from eSchoolBC to eSchool23 is in progress with the intent for confirmation in the spring of 2021.
 - There are currently (as of November 20, 2020) 683 students registered in the newly established synchronous K-9 Program. For students in grades 10 to 12, eSchool23 is providing 1,268 courses to 651 students. The majority of students are taking 1-2 courses. Sixty-seven students are taking 4 or more courses. At the end of the transition period on November 13, 2020, there were 96 students on the waitlist. As of November 20, 2020, 94 students were placed in classes with 2 students remaining on the waitlist. The remaining 2 students were to be accommodated the following week.

The Board Chairperson, on behalf of the Board of Education, expressed their appreciation for all of the work being done in the schools by all staff.
