## National Bullying Awareness Week – November 12 to 17, 2012

The Board of Education declared the week of November 12 – 17, 2012 as "Bullying Awareness Week" in School District No. 23 (Central Okanagan).

# 1. Annual Integrated Pest Management Report

The Board of Education accepted the Annual Integrated Pest Management Report as the Annual Report required in Policy 620 "Site Maintenance".

# 2. Registration Dates for the 2013/2014 School Year

The Board of Education approved the initial registration dates for the 2013/2014 school year as February 4, 2013 through to March 7, 2013, and that the closing date of registrations, in order to apply the Board's registration priorities as established in Regulation 405R "Student Placement" (*Regulations*), be set as August 29, 2013.
