1. Review and Revision of the Current Policy Manual

Advocacy

Update: Board Chairs' Call with Minister of Education and Child Care, Lisa Beare

The Board Chair reviewed highlights of the virtual meeting Board Chairs had with Minister of Education and Child Care, Lisa Beare. Included in the discussion was an advance briefing on the announcement by the Provincial Government on the tabling of Bill 19, which, if passed, will amend the School Act by permitting school districts to operate school age care on non-instructional days, provide birth to five year old care, and recover reasonable costs incurred for the purpose of providing a child care program on board property. The Board Chair also referenced a letter received by The Honourable Bowinn Ma, regarding Bill 27 and the Statutes Amendment Act.
