Date: November 12, 2014

Recognition:

1. Sophia Russo, Grade 11, Kelowna Secondary School

Sophia Russo was recognized by the Board of Education for achieving Top Junior Debater from the Okanagan Region – Victoria Provincials and as being one of BC's delegates to the National Debate Seminar in New Brunswick.

The Board of Education recognized the above five students as \$1,000 winners in the *History Now, Government of Canada History Awards*, along with their teacher, Graeme Stacey.

1. National Bullying Awareness Week - November 16 - 22, 2014

The Central Okanagan Board of Education declared the week of November 16 – 22, 2014 as "Bullying Awareness Week" in School District No. 23.
