Discussion/Action Items

1. Central Okanagan Public Schools eSchoolBC Distributed Learning Program Review – Level 3
Jordan Kleckner, District Principal of Learning Technology, and John Morrone, Vice-Principal of Learning
Technology, presented a review of the seven programs within eSchool BC and Distributed Learning. They shared
a collection of feedback from students, staff and parents, revealing strengths, challenges, and specific
considerations for continued program development to meet diverse learning needs. eSchoolBC is committed to
working alongside schools in Central Okanagan Public Schools, providing quality learning options that address
unique needs in the local learning community.

Outcome:

The Committee recommended that the Board of Education approve the Central Okanagan Public Schools eSchoolBC Distributed Learning Review – Level 3, as attached to the Agenda, and as presented at the March 6, 2019 Education and Student Services Committee Meeting.

The Committee also recommended that the Board of Education support the renewal of the Distributed Learning Agreement with the BC Ministry of Education.

2. Proposal for Substantive Change – Academy of Indigenous Studies (Kelowna Secondary School)

Joannne De Guevara, District Principal – Aboriginal Education, and Ryan Mansley, Vice-Principal – Kelowna

Secondary School, presented a proposal for an Academy of Indigenous Studies at Kelowna Secondary School. The opportunity to offer an Academy of Indigenous Studies at Kelowna Secondary School would provide Kelowna Secondary School students the same course components currently offered at Rutland Senior Secondary and Mount Boucherie Secondary. The Academy of Indigenous Studies is a full 20-credit program for students in Grades 10 through 12 and provides Indigenous and non-Indigenous students authentic, hands-on Indigenous teachings aimed at enriching understanding of the local culture and increasing a sense of connectedness to the school and community.

Outcome:

The Committee recommended that the Board of Education approve the Proposal for Substantive Change – Academy of Indigenous Studies (Kelowna Secondary School), as attached to the Agenda and presented at the March 6, 2019 Public Education and Student Services Committee Meeting.
