1. School Act Class Size/Class Composition Update Report

The Board of Education approved the School Act Class Size/Class Composition Update Report for the month of January 2012. Additionally, the Declaration of Appropriate Learning Situation was approved for submission to the Minister of Education.

2. Proposal for a Modification to the Existing Soccer Academy – Mount Boucherie Secondary School

The Board of Education approved the Proposal for a Modification to the Existing Soccer Academy at Mount Boucherie Secondary School to be implemented beginning in September 2012.

3. Proposal for Substantive Change (Hockey Canada Skills Academy) – Kelowna Secondary School

The Board of Education approved the Proposal for Substantive Change (Hockey Canada Skills Academy) at Kelowna Secondary School to be implemented beginning in September 2012.

4. Amendments to School District No. 23 Policy 220 "Principals and Vice-Principals: Selection, Appointment and Transfer"

The Board of Education referred Policy 220 "Principals and Vice-Principals: Selection, Appointment and Transfer" to the Human Resources and Staff Services Committee to develop amendments to address the appointment of District Principals. The Human Resources and Staff Services Committee will subsequently provide recommendations to the Board.

5. Amended Annual Budget Fiscal Year 2011/2012

The Board of Education approved the Amended Annual Budget Bylaw for the fiscal year 2011/2012 in the amount of \$185,555,254. The amended budget reflects updated revenues and expenses based on actual student enrolment and actual expenditure patterns.

6. Correspondence to the Board

The Board of Education agreed to respond to letters recently sent from the Okanagan Nation Alliance and Westbank First Nation regarding the decision to add another Métis seat on the Aboriginal Education Council.
